- (c) To release and forever discharge Owen Sound Fitness & Training Inc. from all liability for any personal injury, death, property damage or loss resulting from your participation in fitness activities due to any cause, including but not limited to negligence, breach of any duty imposed by law, breach of contract or error of judgement of Owen Sound Fitness & Training Inc. and all of the previous listed associates.
